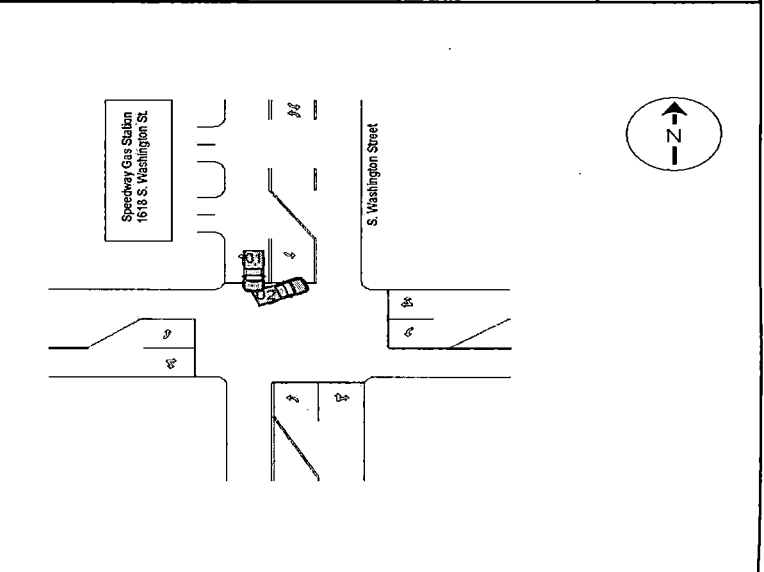

NARRATIVE

Unit 01 stated he was sitting at the red light on S Washington St in the straight lane. Unit 01 states Unit 02 was turning from Walmart to go North on S Washington St. Unit 01 also states that Unit 02 appeared to be on their phone and cut the corner too short, causing Unit 02 to side swipe Unit 01.

Unit 02 stated she was sitting at the red light in the turn lane to leave Walmart and go North on S Washington St. When her light changed green she started to go and make her turn. Unit 02 states that she saw Unit 01 coming toward her and not stopping for the red light. Unit 01 proceeded to keeping driving and struck Unit 02.

Both vehicles were moved off the roadway upon my arrival. I checked with surrounding businesses and found none of them has outside cameras.

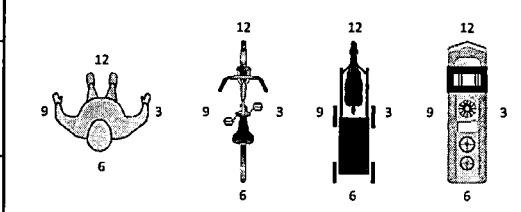
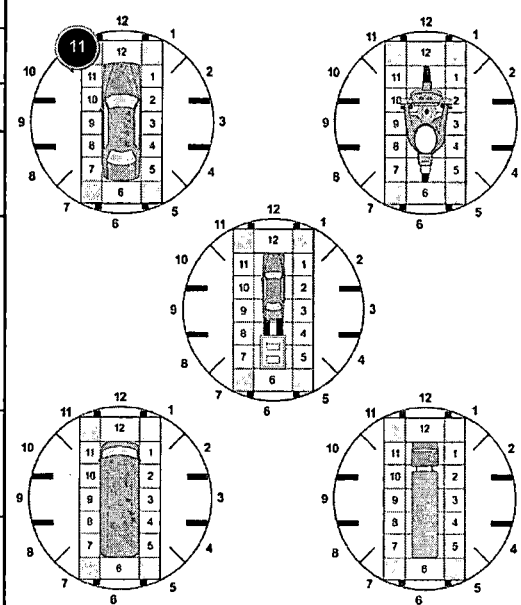

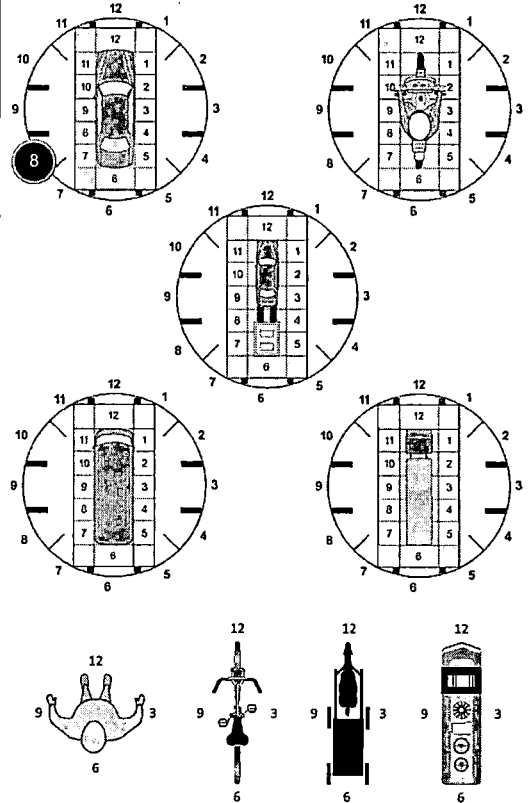
