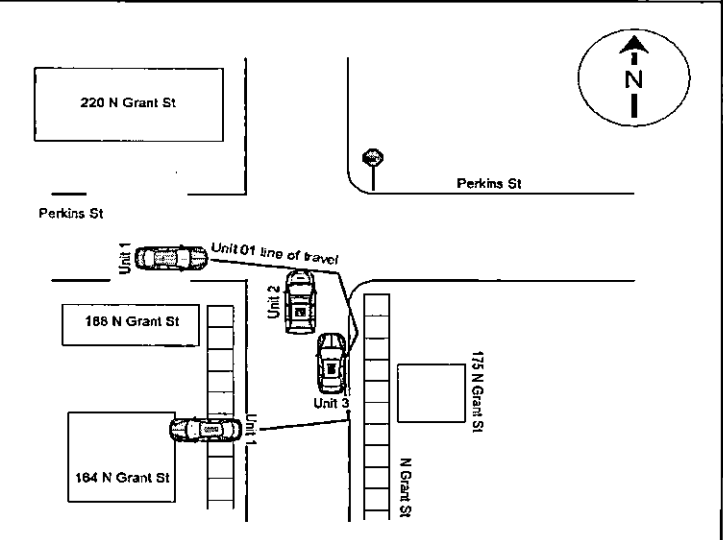

Unit 02 was northbound on N Grant St getting ready to turn into 220 N Grant St. Unit 01 was pulling out of Perkins St crossing traffic on N Grant St. He stated he went to hit the brakes, panicked and hit the gas causing him to continue forward striking Unit 02. Unit 01 continued up onto the sidewalk and sideswiping a parked car in front of 175 N Grant St. Unit 01 came off the sidewalk, crossed Grant St, drove over the sidewalk on the West side of the roadway and struck 164 N Grant St. Unit 01 caused damage to Unit 02, Unit 03, and the residence. Unit 02 stated he was going to turn into his shop, 220 N Grant St when Unit 01 drove out and struck him.

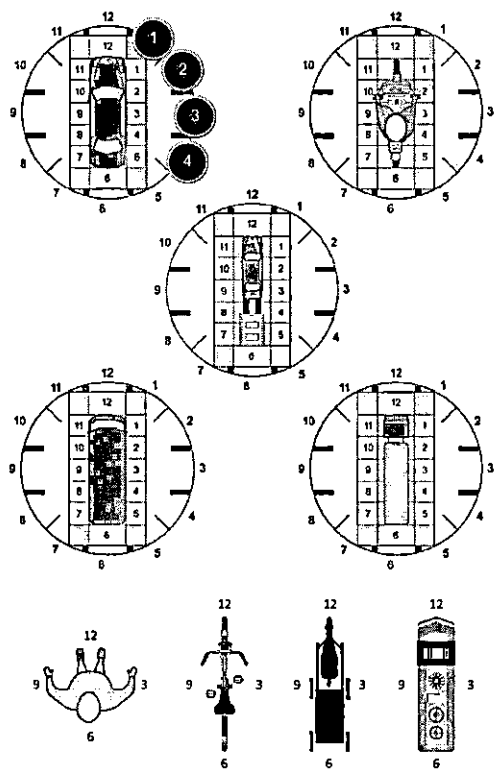
