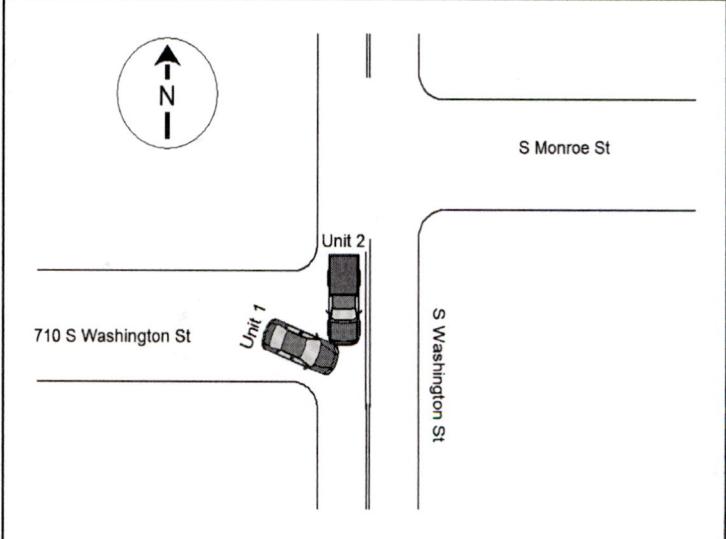

Unit 02 stated he tried to hit the brakes but it was too late as Unit 01 had pulled out in front of him. Unit 01 stated she was stopped and checked for traffic prior to pulling out. Unit 01 stated she saw a semi at the top of the hill but did not see Unit 02. Unit 01 stated Unit 02 did not have head lights. Unit 02 told bystanders there was an alternator issue and was trying to get lights to work. When I arrived on scene, Unit 02 was shut off. When Unit 02 left the scene, everything appeared to be in working order.


