

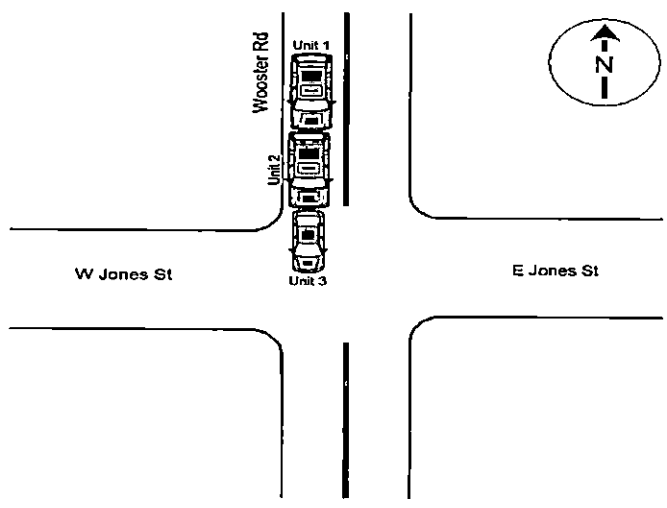

Unit 02 occupants had complaint type injuries of headaches and neck pain, but declined to be checked out at scene. Unit 02 occupants were checked out by Wooster Community ER and the driver sustained a concussion while te passenger sustained whiplash. Unit 02 was ultimately pushed into the vehicle (Unit 03) in front of them, whom was waiting to turn, which did not stop at the scene. Unit 02 stated the Unit 03 was a black car and no other information was able to be obtained.

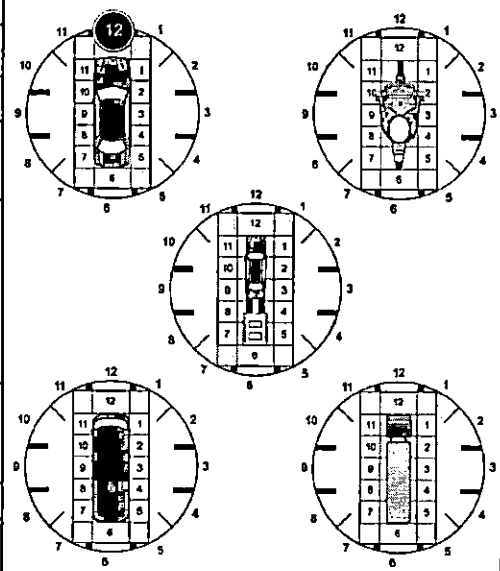

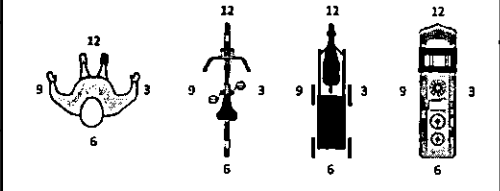

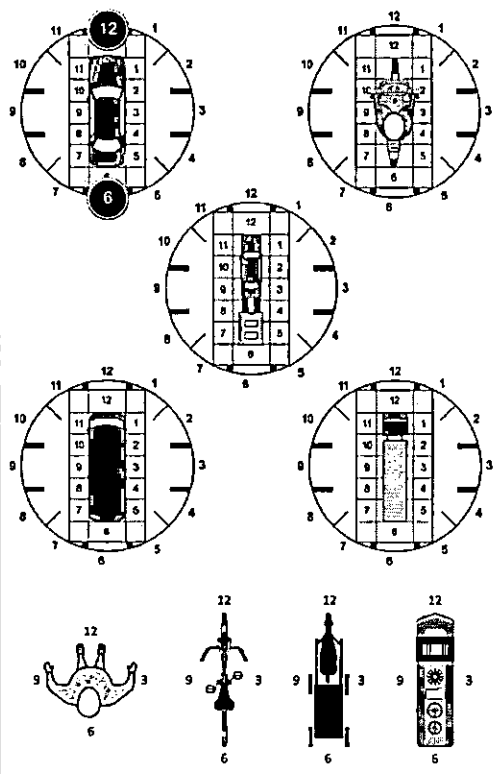
