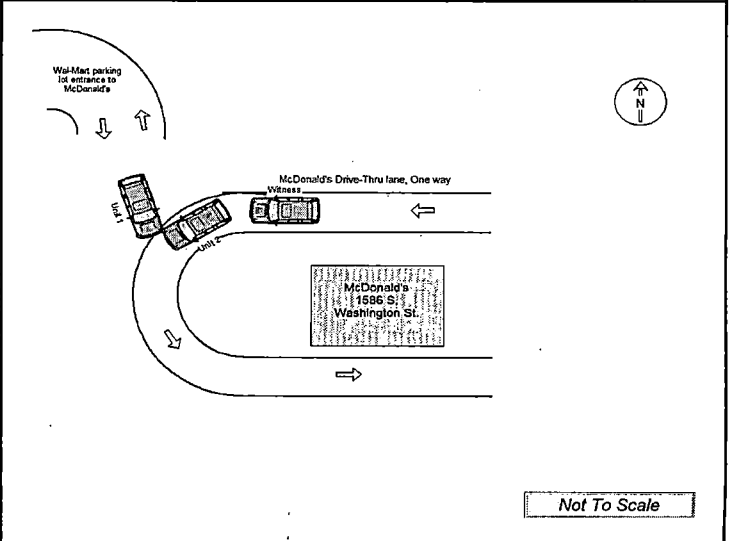

NARRATIVE

Unit #1 entered parking lot of McDonald's from Wal-Mart parking lot, and approached the McDonald's drive thru, that is one way and marked with solid yellow line. Unit #2 was driving in the drive thru lane with several vehicles in front of it. Unit #1 attempted to enter into the drive thru lane improperly. As Unit #2 was still following the vehicles in the drive thru lane, Unit #1 continued to attempt to move its way into the lane when it made contact with the right front bumper of unit #2 and left front bumper of unit #1. Witness in diagram, witnessed the incident transpire. This accident was on private property, but unit #1 is found at fault for not following the proper flow of the one way only traffic, no citation written. Both unit #1 and unit #2 filled out statements on Millersburg Police Dept. witness statement forms. Camera view at McDonalds video did not appear to show where the contact occurred but management will check and contact us if it does.

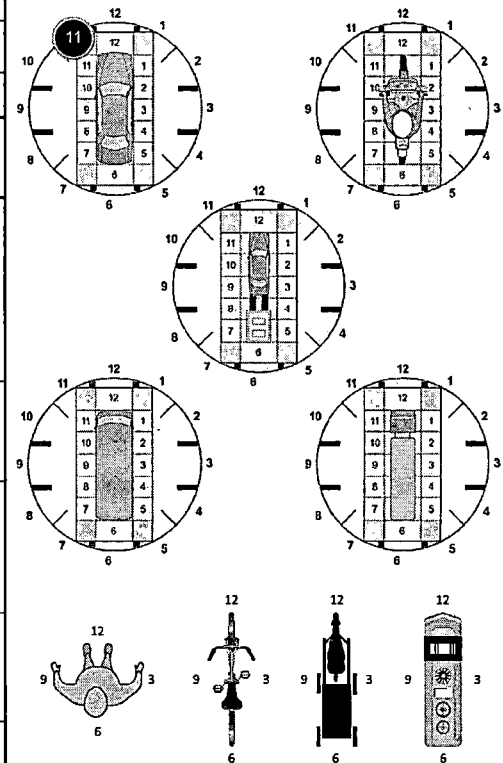
