NARRATIVE Unit #2 stopped at stop sign then pulled forward stopped again as a vehicle was south bound on S. Clay St. Unit #1 struck Unit #2 in rear. Driver of Unit #2 indicated her chest hurt where seatbelt was across her body and declined medical treatment at the time of crash but stated she would go to emergency room later if needed. Driver of Unit #1 said there was room for both units to pull out in front of the uninvolved car coming south. Unit #1 did not see Unit #2 stop again and this is where the contact occurred. Unit #2 indicated the vehicle was pushed forward after contact. Driver of Unit #1 advised he was only going 3 mph and could not have pushed her vehicle forward.
