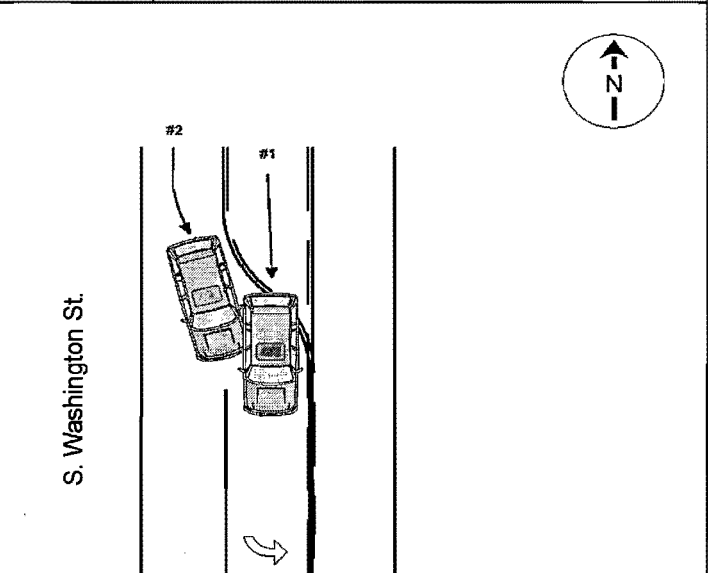

Unit number two was southbound on Washington street when she was entering a left turn lane and struck unit number one. Unit number one was southbound and was passing unit number two illegally.






