

NARRATIVE
Unit # 1 was traveling East on West Jones Street and was crossing Wooster road to get to East Jones Street. Unit # 2 was traveling North on Wooster Road. As Unit # 1 was crossing Wooster Road, she failed to yield at the stop sign to on coming traffic and drove through the intersection, being struck by Unit # 2. Unit # 2 then struck the utility pole. Unit # 1 received damage on the right front side of the vehicle and Unit # 2 received damage to the front of the vehicle. Both vehicles were unable to operate at this time.


