

NARRATIVE
Unit 2 was traveling northbound on South Monroe Street and approaching the intersection of South Monroe and East Adams Street. Unit 1 was traveling southbound on South Monroe Street and attempted to make a left hand turn in front of unit 2. Unit 1 in turn struck unit 2 causing disabling damage to the front end of both vehicles. The driver of unit 1 explained that he thought the intersection was a four way stop. The driver of unit 1 was issued a citation for failure to yield right of way while turning left.


