

NARRATIVE
Unit #2 had pulled out from Logsdon Ave., turning south bound on S. Washington St. Driver of Unit #1 advised he was not looking at the road and when he looked up he struck Unit #2 at full speed with out hitting his breaks. Driver of Unit #1 could not say what he was looking at when not paying attention to road indicatinig his was old. Unit #2 had crossed northbound lane of travel and the center turn lane and had entered the southbound land of travel prior to the crash. Driver of Unit #2 advised he watched Unit #1 could see the driver was looking down until right before the crash occured. Damage began at 23' and 8" down semi and trailer. Unit #1 was disabled and towed from scene by Rigz Towing. Unit #1 could not provide insurance information at time of crash.


WAS VEHICLE OPERATING IN AUTONOMOUS MODE WHEN CRASH OCCURRED? 2


