

NARRATIVE

Unit #1 was south bound on S. Washington St. and struck Unit #2 which was unoccupied and parked legally in parking along roadway. Unit #1 did not stop at the scene after the crash. Owner of Unit #2 advised there was a witness but at this time I have been unable to contact the witness who indicated it was a postal vehicle. Paint transfer on Unit #2 appeared to be yellow. I checked parking lot for post office and was unable to located any vehicles with damage on corresponding area. I was able to speak to the witness on 2-17-21 and obtain a written statement he indicated Unit #1 was a larger box truck that pulled into the post office. I made contact with Millersburg Post Office who indicated that there are several delievery services who make deliveries in box trucks but none of their own.


