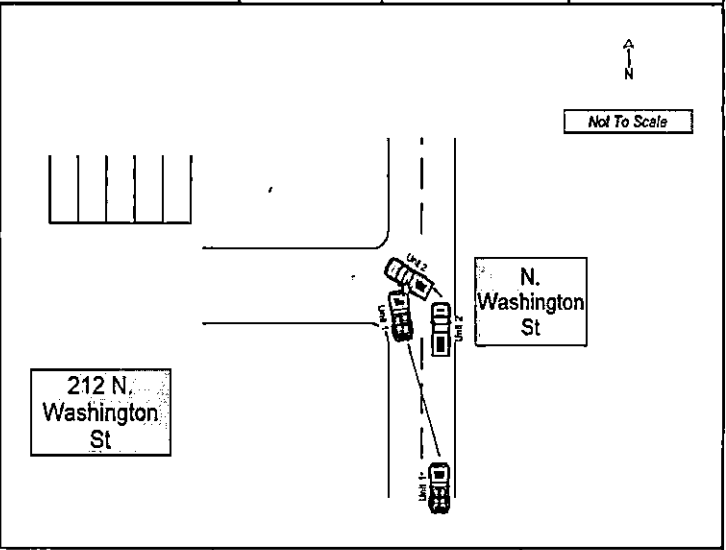

Washington St and did not see the turn signal on Unit 2 and assumed the truck was parked along the road. When Unit 2 went to turn left into the parking lot, and Unit 1 tried to pass on the left and struck the driver side door of the truck.
