# VISITORS

**Eric Strouse**, a Holmes County resident, introduced himself to council as a candidate for Holmes County Commissioner in the May primary. Strouse, a retired banker, owns and operates a hog farm with his son. He served on the West Holmes school board for 20 years, Habitat for Humanity board for 25 years, was a branch manager for Killbuck Savings Bank for 16 years, and was employed by Farm Credit for 8 years. He told Council he is very familiar with the agriculture end of the community, and feels with his banking experience and being a lifelong resident of Holmes County, he would be a good candidate for commissioner.

Renee Woods, Millersburg Elementary School Principal, told Council she was concerned about the safety of children using the crosswalk at the school while vehicles veer around the pickup line near state Route 241. Parents have asked why North School Street needs to be one-way and she doesn't have an answer for them. She asked for the history on the one-way restricted hours. Councilman Vaughn, (former police chief of Millersburg), said the road was designated one way during restricted hours for school buses coming primarily from the east, and turning onto North School Street from East Jackson. Vaughn continued, buses can't make the turn if there are cars sitting there. Vehicles could still get out onto Jackson by going down East Liberty Street and exiting by the Mennonite Church. That was done at the request of the school, approximately 30 years ago. Woods noted that currently, buses enter the parking lot from the north side of the building, off of SR 241, and she questioned if the one-way is still needed. Woods said, recently the Millersburg Police Department has been stopping vehicles in the afternoon for going left of center around the pickup line that's going into the school to pick up students. She believes the old traffic pattern is not the best for student safety, noting buses enter Millersburg Elementary from 241, and exit from the front of the school directly onto Route 39. Buses aren't coming down North School Street at all anymore, she noted. Another issue is, when cars circle around the pickup line and pull out onto North School Street, if they want to go down to 39, they go down the alley by the church. She doesn't feel that is the safest place to exit when there are kids walking downtown, since there are no crossing guards at that location. There are guards at the bottom of North School Street. Administrator Troyer suggested covering the one-way signs and giving the new traffic pattern a test run and if officials find that it is working, the signs can be removed. Council agreed to try the new traffic flow pattern temporarily, if all buses are told to use Route 241 for entrance to the school, and asked Woods as well as the Police Department to monitor the situation. If the matter is working, the signs will be removed. West Holmes Superintendent, Eric Jurkovic, accompanied Woods at the meeting.

She has accepted a position with the Holmes County Sheriff's Office. Motion made by Vaughn to accept the resignation. Seconded by Hoffee. Upon roll call, motion carried with Vaughn, Hoffee, Polen, Conn, Hofstetter, and Shoemaker voting aye.

<u>DRB & P&Z Commission:</u> Informed Council there were no submittals for February, however, there will be a sign review for Troyer Sweet Shoppe for DRB. Troyer also noted he anticipates we will have the final site plan review for the Stenwood Development for P&Z in March.

<u>Resurfacing/Sidewalk Projects:</u> Informed Council there is no update other than resurfacing plans are underway. He will also have work done on bringing a few manholes up to grade on S. Washington St.

and Massillon Rd. Proposals are being put together for the infrastructure projects of Wooster Rd. waterline and N. Grant St. storm sewer.

<u>Comprehensive Plan:</u> Informed Council the community survey is out and available on our Facebook page. He encouraged everyone to complete the survey.

<u>163 & 187 N. Crawford Street Demolitions:</u> Informed Council he continues to work with Arnie Oliver on the application for demo funding of the two properties on N. Crawford St.

E. Jones Street Reconfiguration: Informed Council, AEP engineers have reviewed the proposed work for the E. Jones/Wooster Rd intersection. This will be a difficult redesign for them as it will require installation of additional poles around the intersection. They will perform this work at no cost to the Village. They would like a commitment from Council that the Village will complete their portion of the work, before they will begin their pole relocations. Council agreed to complete the Villages' portion of the project. Once the pole is removed and others are relocated, the Village will remove the guardrail, pave, and stripe the area. In an unrelated matter, Mayor Huebner asked Troyer to speak with AEP about the possibility of installing street light out to Meadow Glen. Troyer agreed and also noted he received a request for street lights on CR 58 out to Autumn Run. Hofstetter asked if sidewalks could be installed along CR 58 to Autumn Run. Troyer said the lay of the land on the north side is not conducive, however, the south side may be feasible.

<u>CRA Legislation:</u> Informed Council, we have legislation on the agenda for a proposed CRA agreement that will result in B&L Transport building a new facility on the vacant lot beside Tractor Supply for their trucking operation. The building will be 19,000 sq. ft. and will bring with it their 100 employees, as well as 28 future employees. The building will house their office and the truck maintenance facility. This is a great addition to the Village, and we look forward to working with the Mast family to see this through to completion.

<u>Dump Truck Replacement/Street Lighting:</u> Informed Council he requested quotes for trucks from two different Sourcewell vendors and have a meeting with one this week. He hopes to have a viable option in the next few weeks to proceed with an order.

**Street Lighting**: Informed Council he is currently working on soliciting proposals from engineering firms for the design/bid portion of the street lighting project.

<u>Personnel:</u> Informed Council he has an item for executive session to discuss the promotion/transfer of employees.

<u>Appreciation:</u> Lastly, Troyer thanked all of the Utility and Street Department staff for their efforts the last few weeks. Between water leaks, snow and ice removal, and the day to day demands of the job, they have been extremely busy. They have all done a great job and it very much appreciated. Troyer also thanked all of the residents and business owners who have gone out of their way during these times to offer a drink, food, or word of thanks and appreciation.
