**DISCUSSION:** Shaner stated that members of the department are doing a "no shave" charity fund raiser from November 1 to March 1, 2022. Money collected from the members participating will go to two different charities. First two months will go to Share-A-Christmas and the last two months will go to Akron Children's Hospital.

**DISCUSSION: DRB & P&Z Commission:** DRB met on 11/3 and approved the elevator/stair addition at 20 E Jackson St (American Hall Building). P&Z approved a variance for additional signage at Save and Serve as well as a lot split for the former Health Department to help facilitate the transfer of that from the county to Pomerene.

**Resurfacing / Sidewalk:** Melway completed the full depth repair at the intersection of E. Jackson St / N. Crawford St (SR 241) on 11/4. This completes the 2021 project. Troyer stated that he has started putting together resurfacing projects for next year and hopes to get with the engineer soon.

**Comprehensive Plan:** The final workshop will be held at Harvest Ridge and scheduled for Wednesday, November 17, from 5:30 pm to 7:00 pm with Tourism as the evening's topic.

**Downtown Signal Project:** Offset traffic signals were installed last week at Monroe and Washington St. The contractor is waiting for the rest of the equipment to complete the project. Huebner asked if radar detection at the square was working. Troyer stated that radar detection at the square is connected and working.

**Leaf Pickup:** Troyer stated that leaf pick up has started. They had a mechanical issue earlier but should be up and running tomorrow. They are ahead of schedule due to weather. The schedule and information are posted on the Village Facebook page. Any resident with questions should contact the Village Office at 330-674-1886.

**Utility Department:** Blake Judson received his Class I Wastewater License near the end of October. He will receive a 10% pay increase per our ordinance. Congratulations Blake!

**Credit Request:** Evelyn Wooten had a substantial leak under her concrete pad between the meter and the house, located on Critchfield Street. Requesting credit for 81,000 gallons in the amount of \$135.30 for the sewer portion of the water bill and waiving late fees. Also requesting a credit of 40,000 gallons in the amount of \$92.00 for the  $4^{th}$  quarter billing.

**DISCUSSION:** Annual interfund transfers from the Water Fund to the Water R & I Fund (\$7,500.00 per Ordinance 84-7) and the annual transfer from the Sewer Fund to the Sewer R & I Fund (\$10,000 per Ordinance 80-4) are completed.

**Monthly Financial Report**: All council members acknowledged that they received the financial report for October 2021 that included the Bank Reconciliation, Appropriation Summary, Fund Summary, Revenue Summary, Payment Summary, and Payroll reports.

**Bed Tax Applications for 2022:** Cool-Miller stated that we have received all of the Bed Tax Applications. Hoffee stated that she is aware that Ordinance 2016-104 states how the bed tax money is divided. However, she has a concern with the severe deficit that the Historical Society is showing, as of October 31. She stated that they do have multiple avenues of income, however, we are historical Millersburg, and the Historical Society is a huge part of that, along with the Victorian House. She stated that we may want to revisit that ordinance and possibly change the percentages. Huebner stated that the pandemic has been a cause in decline for them, however, they are coming back. Also, their letter writing campaign just came out so we don't know how that will do. He stated he would like

to see how this works out, so maybe we can revisit it next year. Troyer stated that their admission fees is a lot of their income. Huebner agreed that there are usually busses and there haven't been any since the pandemic. Hoffee stated that the Victorian House is in need of repair now. Huebner stated that they normally go for grant money for that. He stated that Mark has never indicated they needed more from us. Hoffee stated that we can keep it as it is this year, however, we do need to look further into it next year before the applications are due. Shoemaker agrees. Huebner stated that midsummer would work to revisit this. Shaffer spoke up and stated disbursements aren't done until January. Hoffee stated she would like each group to know how much they would be getting prior to applying.
