## Holley Johnson & Michelle Wood – Appalachian Community Grant

The Appalachian Community Grant is part of a \$500 million grant that originated with the American Rescue Plan Act. 32 Ohio counties were eligible to apply for the grant. A steering committee was formed and was awarded a small grant that allowed the committee to hire Johnson and Wood. Along with the committee and a state procured planner, they put together the projects that were submitted for the grant. To apply for the grant, the committee had to go through a development district, OMEGA, a tencounty region of Ohio. Lots of work and planning went into the proposed project ideas. A total of 90 projects were submitted through OMEGA. Only 41 of those were approved to be submitted to the Ohio Department of Development. 4 of those 41 project were submitted from Holmes County. The focus of the projects for Holmes County was Ecotourism, connecting to the Holmes County Trail. The 4 projects submitted for Holmes County total about \$15 million. The Holmes County Trail is heavily used. The goal is to bring the people that use the trail into the Villages of Holmesville, Millersburg, Killbuck and Glenmont to eat, stay, shop and have something to do. In Millersburg they proposed a multi-use path from The Depot at the Trail to the downtown area. The other exciting project submitted was water access. They want to have a water access point installed close to the bridge near the Depot allowing people to launch their kayak and then kayak all the way to Killbuck, where another launch ramp would be installed. If the grant is awarded, \$1,140,000 would go into the project in Millersburg.

### Holley Johnson - Candidate for Holmes County Commissioner

Holley Johnson resides in Winesburg with her husband and children. She has lived in Holmes County for 16 years and Holmes County is her home. She feels that it is important to protect the values in our community. She believes that she has proven that she can get projects done. Johnson is the Executive Direct for The Holmes Center for the Arts which started with nothing and now has over 600 hundred students. Johnson has learned grant writing, how to run a business and set up an endowment fund. She has talked to legislators and lobbied for the arts, bringing in over \$1 million for the arts in Holmes County. Johnson discovered through her involvement with the Appalachian Community Grant that she can accomplish more and serve Holmes County to get work done. She would like to use her talents and unique skillset to serve Holmes County as commissioner.

## Steve Johnson - Candidate for Holmes County Commissioner

Steve Johnson is here to introduce himself. He was raised in Holmes County and graduated from West Holmes in 1989. He then joined the US Airforce and served oversees in many countries. Johnson, after his military career, returned to the United States and became a truck driver. In 1995, he was nearly killed in a motorcycle wreck. During his recovery in the hospital, he found God started serving the Lord. After recovering, Johnson used the GI Bill to go to college. He attended Kent State, Cincinnati Bible College, Xavier University, and the College of Mount St. Joseph, which is where he became interested in politics. He served as an intern for a congressman while in college. He became very familiar with government and politics. He knew at that point he wanted to serve in government. He went on to earn his master's degree at Mount Vernon Nazarene University and a Master Certificate from Texas A&M. In 2008, he ran for State Representative in the Cincinnati area. In 2016, Johnson ran for State Representative in the Holmes County area. In July of 2023, he made the decision to run for Holmes County Commissioner. Holmes County is a special place. He is looking to do three things as commissioner - Preserve our culture, Promote Economic Opportunity, and Prepare for the Future. He wants to get things done.

## **DRB & P&Z Commission**

P&Z Commission met December 6<sup>th</sup> to review a change of zoning use request from Jon & Molly Lotut for 4 parcels adjacent to the trail, off Hickory St. The request is to change the

zoning from R-3 to SU to allow for the construction of a mixed-use residential property to include short- and long-term rentals and primitive camping areas. The Commission recommended approval of the rezoning request. We need to set a public hearing date and time-January  $22^{nd}$ . Hearing set for 1/22/24 at 6:45pm.

There was also a request to consider allowing the use of a shipping container if it were modified to have traditional storage facility features (roof, doors, siding etc). Council members agree that this request warrants more discussion and looking at the ordinance prohibiting the use of shipping containers in the village. Discussions take place and research needs to be done. Troyer and Solicitor Hines will research and this topic will be discussed at a later date.

November Financial Statement were previously emailed to Council and the Mayor. Acknowledgment signed by all.

The Village has a current three-year agreement with the Ohio Municipal Joint Insurance Pool for our property and liability coverage. Our rates will change only as we add or remove coverage on vehicles and property. While the agreement is in effect, with written notice, we can opt to bid our insurance coverage out. Historically, The Ohio Municipal Joint Insurance Pool has offered the lowest rates for the coverage the village needs. We have been with them for 28 years. Curry and Shaffer asked council if they are interested in bidding coverage out. The consensus of council was to stay with the company we have for the duration of our agreement.

Shaffer congratulated Curry on completing 1 year of employment with the village as Assistant Fiscal Officer. Shaffer has confidence in Curry and believes she will do a good job for the village in the future. Shaffer would like to recommend that Curry's probationary status be removed.

Motion to remove probationary status for Bobbie Curry made by Hofstetter. Seconded by Shoemaker. Hofstetter, Shoemaker, Polen, Conn, Hoffee and Vaughn all voted yes. Motion carried 6 yes, 0 no.
